TERMS AND CONDITIONS

CANCELLATION:

a. CANCELLATION OF EVENT: In the unlikely event of cancellation of the ASIA Seminar due to any Force Majeure event (i.e. fire, strikes, governmental regulations, terrorism, or other causes which prevent or make the same commercially unreasonable for its scheduled opening or continuance), then and thereupon exhibitors and ASIA have no further obligation to one another, and ASIA shall determine an equitable basis for determining any refund of the Exhibit booth fee, after due consideration of expenditures and commitments already made.

b. CANCELLATION BY THE EXHIBITOR: Exhibit space that has been assigned and confirmed may be canceled by written notice to asia@azselfinsurers.org. If notice of cancellation is received: Before October 17, 2022 --Exhibitor forfeits 50% of total cost for exhibit space assigned. On or After October 17, 2022 - Exhibitor forfeits 100% of total cost of exhibit space assigned. *NOTE: It is the exhibitor's responsibility to cancel all other arrangements made in connection with exhibiting.*
